### **Minutes of Meeting**

Date: 06/08/202

On August 3, 2024, the meeting of the “Anti-Ragging Committee” was held, and the following are the minutes of the meeting.

#### **1. To read and confirm the minutes of the previous meeting.**

Prof. Dr. Jayendra Khot Registrar, read the minutes of the previous meeting held on August 3, 2024, and confirmed by all the members.

#### **2. To take note of the action taken reports of the last meeting and confirm the same.**

The documents were prepared and uploaded in the website of DYP-ATU, Talsande. In addition, the posters were also prepared and to be displayed in various locations on campus.

#### **3. To take note of the circulars received from UGC on anti-ragging.**

The committee members have discussed circulars received from UGC regarding anti-ragging. The UGC has published circular on 27 Feb, 2024 regarding the authorisation letter for the Centre for Youth (C4Y) by UGC.

It has been mentioned in the circular that UGC has selected an NGO called the Centre for Youth (C4Y), which communicates with any college or university in India on behalf of UGC for compliance with UGC's regulation on “curbing the menace of ragging in higher education’s institutes in 2009.

The second circular was about the revised procedure for anti-ragging undertaking and compliance submission. As per circular, the Anti-Ragging Undertaking must be filled out by the students, online at <http://www.antiragging.in> only.

With addition of it, Prof. Dr. Jayendra Khot suggested signing MoU with NGO “Krushi Samarpan” for various activities regarding ant-ragging and surprise visits for hostels, and everybody agreed with that.

Prof. Dr. Jayendra Khot mentioned to fill online anti ragging affidavits at the beginning of new academic year by the students.

### **5 To discuss on display notices and boards of the Anti-Ranging Committee and Squad on the website, campus, and hostel areas.**

Dr. Vikramsingh Ingle and other members discussed that our anti-ragging committee boards are ready and displayed in various areas like the girl's hostel, boy's hostel, canteen, cafeteria, library, and lobby, which will be helpful to the students to approach the anti-ragging committee.

### **6. To take a note on the squad report:**

Dr. Sadashiv Kalyan and squad members conveyed that they have visited boys's hostels and girls's hostel on May 15, 2024. Squad members interacted with junior and senior students. Both boys and girls hostel students were informed that there are no incidents of ragging in the hostel. Students have been instructed not to go outside campus without the prior permission of the rectors. The students want to add the details to the muster if they are going outside. Squad members instructed the students to follow mobile etiquette inside the room to avoid disturbing other students who are studying. A detailed squad report has been submitted for documentation to Dr. Malati N. Khokle.

### **7. To take note of the Anti-Ragging Week Celebration Arrangements, which will be held on 12 August, 2024 to 17 August, 2024.**

It is decided in the meeting to conduct activities like expert lectures and poster presentations, which help students create awareness about anti-ragging. Also, Dr. Mangal Patil has suggested that to conduct an informative street play. All the members agreed with this decision.

### **8. Any other points are to be discussed with the permission of the chair.**

Hon. Vice-Chancellor Prof. Dr. K. Prathapan advised creating a WhatsApp group for the smooth functioning of the committee. In the meeting before the commencement of the academic year during the induction program, departmental heads will take a session regarding awareness of anti-ragging and their rights.

Prof. Dr. Jayendra Khot, suggested that departmental heads should ensure each student informs his or her place of residence while pursuing the course, whether
